



WIRE TRANSFER AUTHORIZATION

This Wire Transfer Authorization is between the undersigned Member and Pacific Cascade Federal Credit Union ("PCFCU") and provides the terms and conditions to process wire transfers on my/our account. This Authorization governs all wire transfer requests that are initiated from your account. Please note there may be a delay of up to three business days from PCFCU's receipt of this authorization before transfers are functional.

SECURITY MEASURES

For your security, PCFCU will perform a successful callback or verification prior to finalizing your Wire Transfer request. We will only call phone numbers that have been on file for a period of at least 30 calendar days. Each wire transfer request shall be verified by password/phrase and/or Call Back verification. PCFCU shall telephone the Member at the designated phone number(s) to receive final verification requesting the current password/phrase, if applicable.

Call Back Password or Phrase — In order to verify and authorize a Wire Transfer Request, you must specify a password/phrase to be used when we perform the call back. This password/phrase needs to be something that cannot be found in public databases about you, and may not be the same as your PCFCU account code word.

*Photocopy of Identification is required to be on file at PCFCU in order to submit a wire request.

Notice

I/We understand when initiating a wire transfer, I/we may identify either the recipient or any financial institution by name and by account or identifying number. PCFCU and other institutions may rely on the account or other identifying number I give, even if it does not match the party named in my instructions. Wire transfer requests, changes, and cancellations received after 1:30pm Pacific Time will be processed as of the following business day. You acknowledge that wires initiated after 1:30pm Pacific Time may be delayed until the following business day.

Acknowledgment

I authorize PCFCU to accept Wire Transfer Requests in the manner authorized above to execute wire transfers to the named beneficiary, from time to time, in such amounts to be specified in each Request. Each Request must include the password/phrase we select. PCFCU may accept and execute any Wire Transfer Request that includes the password/phrase. I agree that this is a commercially reasonable security procedure for verifying Wire Transfer Requests, and that PCFCU need not take any further action to verify the authenticity of any request received in this manner. Wire transfers are subject to the terms of this Wire Transfer Authorization, the Wire Transfer Agreement and Membership and Account Agreement, which are incorporated herein by this reference.
